5. CONSENT AGENDA

- C. Approve a purchase up to \$4,000 for a mower for the district. The Bigfork fire hall has been contracted out for mowing the past several years and equipment must be rented to mow the Echo Lake Fire hall. The annual cost for yard maintenance for both halls is approximately \$1,200-\$1,300 per year. If the Board approves the purchase of a riding mower, the employees will perform this duty.
- **E.** Approve the 2021 GIS audit results as presented. 2021 audit results for Bigfork Fire District have been received and verified as presented by Chief Patton and Operations Chief Hingiss. Letter to be signed by the Chairman and sent back to the county.
- F. Approve a one-time vacation payout for Patton updated: The district received updated information from the County Attorney. Vacation should be paid out at the current rate when it is used for anyone. Patton could take the time off at the current rate, but Patton has agreed to be paid out at his current rate of \$26.68/hr. for 250.50 hrs., to be paid on June 1st, 2021.
- G. Recommendation to hire Kaitlyn Barnhart as a PRN paramedic
- **H.** Approval to hire 2 PRN EMT-B's: Emma Kreider and Michael Martinez are both new EMT's that live in the Bigfork Fire district. I recommend hiring both as PRN EMT's.

B. Appointments for Board of Trustees Members-Dan Elwell & Seth Price
On May 4th, 2021 Flathead County Board of Commissioners appointed Dan Elwell
and Seth Price for Bigfork Rural Fire District for a term of June 1st, 2021 through May
31st, 2024.

8. NEW BUSINESS-ACTION ITEMS/DISCUSSION ITEMS

- A. Approval of Recommended Terminations/Resignations of RS, DM, TG, ES DM and TG have already submitted letters of resignation. ES is requesting to change his status from part-time paid employee to a volunteer employee. Borges will have updated status on RS.
- B. Approval of increased health insurance benefit for supervisory employees
 Per discussion with Elwell, supervisory employees are requesting a 10% increase in
 monthly maximum Department contribution for health, dental, and vision
 insurance. This would increase the monthly maximum contribution from \$983.33
 per supervisor to \$1,081.67 per supervisor. This will help offset the substantial 30%40% premium increase that some employees received.
- C. Approval of wage increase(s)

The last wage increases for the Office Manager and EMT-P's were January of 2019. The last wage increase for all EMT's was July 2020. Other supervisors are in a probationary status and will be addressed at the end of the probationary period.
